GENERAL INFORMATION

Transition to NMLS

Companies holding the South Dakota Division of Banking Non-Residential Mortgage Lender License are able to submit a license transition request through NMLS by filing a Company Form (MU1) and an Individual Form (MU2) for each of their control persons. The Non-Residential Mortgage Lender License will be available in NMLS to submit the transition request starting July 15, 2019. The transition to NMLS for this license is optional but highly encouraged.

Note: If you already have a record in NMLS and have submitted these forms in the past, you do not need to re-enter your company information into NMLS. You will only need to identify the business activities your company conducts and the states in which the various activities are conducted. Then, you will select the appropriate license in SD, and complete a few state-specific fields.

It is important that current licensees have the appropriate transition number available when completing and submitting their Company Form (MU1), so they are not charged a new application fee.

Please use your current South Dakota Non-Residential Mortgage license number as the transition number.

Example: ML.012345-NR

SD encourages current licensees to update their information with SD at least one week before they intend to transition to NMLS, so there will be no pending changes to submit at the time of transition.

Any company who, for valuable consideration, originates, sells, or services nonresidential mortgage loans, shall apply for, and maintain, a nonresidential mortgage lending license-- [South Dakota Codified Law \(SDCL\) 54-4-13.5](#)

Activities Authorized Under This License

- Commercial mortgage brokering or lending

Document Uploads Guidance

Documents that must be uploaded to the *Document Uploads* section of the Company Form (MU1) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).
- Only upload documents relevant to the company transition.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Surety Bonds), be sure to indicate the applicable state.

Financial statements should include a balance sheet, income statement, and statement of cash flows and all relevant notes thereto. If applicant is a start-up company, they must provide financial statements for any owner(s) listed in the Direct Owners and Executive Officers field in Form MU1. Note: Financial statements are uploaded separately under the Filing tab and <i>Financial Statement</i> submenu link. See the Financial Statements Quick Guide for instructions.	NMLS

The South Dakota Division of Banking does not limit the number of other trade names. However, all DBA’s must be registered with the South Dakota Secretary of State. Please provide proof the DBA name(s) are registered with the South Dakota Secretary of State.
